A nonresident property owner to be eligible to vote must be owner of record for a period of six (6) months immediately preceding the date of the Annual Municipal Election (October 16, 2015) and shall have one vote provided he or she is registered on the "Books of Registered Voters maintained at the City Hall. The City of Seaford has independent registration procedures for the Annual Municipal Election. To vote, you must meet the eligibility requirements and be registered on the "Books of Registered Voters" maintained at City Hall.

All voters will need to show proof of residency which may be a State of Delaware driver's license, a State of Delaware identification card, a federal or state tax return with address, a City of Seaford utility bill or real estate property tax bill, or other acceptable proof of residency or ownership.

Re: Employee Benefit Committee Recommendation

The Employee Benefit Committee met to evaluate various options for health insurance. We met with INTEGRA and we reviewed the information from the various insurance carriers.

The committee recommends accepting the quote from Unimerica Option 7a, our current carrier. We are also recommending the plan modifications that are attached. With the recommended option the health plan projected costs are decreasing by 9.16% from the prior year and the maximum costs are decreasing by approximately 10.33%.

The employee's share of the premium will remain the same as last year which results in the employee paying the following amounts per week:

Single Coverage	\$11.48 (Increase of \$0.00)
Employee/Spouse/Family Coverage	\$99.81 (Increase of \$0.00)
Employee/Child(ren) Coverage	\$63.98 (Increase of \$0.00)

Recommended Health Plan Modifications:

- 1. Recommend to change the Pharmacy Benefit Manger from CVS/Caremark to 4D/Magellan Health. Estimated savings are \$25.9K including rebates of \$15.9K based upon our claims experience.
- 2. Recommend to accept Employee Withholding as presented.

RE: Bids - Senior Center Additional Parking

The City of Seaford received bids for the above referenced project on April 6, 2017. Attached is the bid tabulation which shows we received four bids for this project that range from the low bidder of \$102,830.57 to a high of \$165,210.10.

Representative Short through the Community Transportation Fund had provided \$43,872.50 and the City had agreed to provide \$21,936.25 in local funding based on the original estimate of \$65,808.75.

A section of sidewalk and storm water containment was added after the estimate. However most unit pricing was also higher than the estimate. With the combination of all the work and pricing changes the bid came in over the estimate by \$37,021.82. When you review the bid tabulation it is evident the City did receive a very competitive low bid which was \$16,411.63 below the second low bidder. The City has worked with Kent Construction on prior projects and they are a reputable contractor with a quality work record with us.

I did contact Representative Short for additional funds and he is willing to share the additional cost as a 50/50 split which is fair. The City and he believe this project will enhance the visitations to the Senior Center, an improved area for the walkers and bikers, and easier access for employees and visitors who park on Locust Street. In addition some minor improvements for the drainage in this area.

Therefore each of us will provide an additional \$18,510.91 to be able to award this project. CTF will provide \$62,384 and the City will provide \$40,446.57. The City's share will be paid out of the Fees for Street Maintenance Reserve which as of March 31, 2016 had a balance of \$239,632.20
