MINUTES OF THE MEETING OF THE CITY OF SEAFORD PLANNING AND ZONING COMMISSION

February 6, 2020

Commission member, Rick Peterson, called the meeting to order with the following Commission members in attendance: Mark Grassett, Al Temple and Matthew Shaffer. Building Official, Mike Bailey was also present.

Mr. Peterson closed the regular meeting of Planning and Zoning at 7:09 p.m. and opened the Public Hearing. He then turned the meeting over to the Building Official, Mike Bailey.

Mr. Bailey then presented New Business #1, Park Venture East LLC, located at Lot 7, Venture Dr., Tax Map and Parcel # 331-5.00-4.27, requesting a Preliminary Site Plan review to construct six (6) flex space units totaling 43,000 sq. ft.; Zoning M1- Light Industrial.

Mr. Bailey stated that the six (6) flex warehouse spaces will include (2) 9,000 sq. ft., (2) 7,500 sq. ft. and (2) 5,000 sq. ft. warehouse buildings. Ninety-five +/- parking spaces will be provided; 43 are required by code (1 per 1,000 sq. ft.) Stormwater will outfall to the existing pond in Ross Business Park and water and sewer will be onsite. The project requires approvals from the State Fire Marshal, Sussex Conservation and the City's Engineer for stormwater.

Mr. Bailey stated that Kent Peterson, property owner and Ring Lardner, engineer, were present to answer any questions.

Commission member, Rick Peterson, solicited any questions or comments from the commission members;

Commission member, Mark Grassett, referenced the presented plans and asked the reasoning for getting rid of the cul de sack that was existing on the lot.

Mr. Lardner came forward to state that the cul de sack was not serving a purpose so they are removing it.

Mr. Peterson asked if the electric will be provided by the City.

Mr. Bailey stated yes.

Mr. Peterson also asked what would be the expected truck traffic; ex: tractor trailer, etc.

Mr. Lardner stated that it will be dependent on who occupies the warehouse space. However, given what they presume will be in the buildings, they are expecting both small and large box trucks and possibly tractor trailers, however that would be less frequent.

Mr. Temple asked if the loading docks that were presented on the plans will service all buildings.

Mr. Lardner stated yes.
