#### INFORMATION FOR BIDDERS

**BIDS** will be received by the City of Seaford (herein called the "Owner") at the office of the City Manager, City Hall, 414 High Street, Seaford, Delaware until 1:30 p.m., prevailing time, on Wednesday, September 7, 2022, and then publicly opened in the City Council Chambers and read aloud.

**BIDDERS** are advised that the bid for materials and services only, for a **2022 One Ton 4x4 Service Truck and Snowplow.** All applicable destination, freight or other charges shall be included in the price provided by the bidder.

The equipment specified herein is to be operated over the roadways, any equipment provided by the vendor must meet or exceed all applicable Department of Transportation, Federal Highway Administration, OSHA and all other applicable safety requirements regardless of the specifications provided herein. All equipment must be able to be legally tagged within the State of Delaware by the vendor for the City of Seaford.

Each BID must be submitted in a <u>sealed envelope</u>, addressed to the City Manager, City of Seaford, City Hall, 414 High Street, P.O. Box 1100, Seaford, DE 19973. Each sealed envelope containing a bid must be <u>plainly marked on the outside as "Attn: City Manager, 2022 One Ton Service Truck" and the envelope should bear on the <u>outside the name of the BIDDER and their address</u>. If forwarded by mail, the sealed envelope containing the BID must be enclosed in another envelope addressed to the OWNER. Any BID received after that time and date specified shall not be considered.</u>

All BIDS must be made on the required BID proposal form. All blank spaces for BID prices must be filled in, in ink, or type written, and the BID form must be fully completed and executed when submitted. One copy of the BID form is required. BIDS and/or alternate bids submitted by FAX will not be accepted.

The OWNER may waive any informalities or minor defects or reject any and all BIDS. Any BID may be withdrawn prior to the above scheduled time for the opening of the BIDS or authorized postponement thereof. No BIDDER may withdraw a BID within thirty (30) days after the actual date of the opening thereof.

BIDDERS must satisfy themselves of the accuracy of the required work in the BID documents by a review of the CONTRACT DOCUMENTS. After BIDS have been submitted, the BIDDER shall not assert that there was a misunderstanding concerning the location, use of property or conditions outlined in the CONTRACT DOCUMENTS.

Information obtained from an officer, agent or employee of the OWNER or any other person shall not affect the risks or obligations assumed by the CONTRACTOR or relieve them from fulfilling any of the conditions of the contract.

The OWNER may make such investigation as they deem necessary to determine the ability of the BIDDER to provide the necessary materials and equipment to carry out the work and the BIDDER shall furnish to the OWNER all such information for this purpose as the OWNER may request. The OWNER reserves the right to reject any BID if the

evidence submitted by, or investigations of, such BIDDER fails to satisfy the OWNER that such BIDDER is properly qualified to carry out the obligations of the Agreement. A conditional or qualified BID may be reason to disqualify your bid.

Award may be made to the lowest, responsible BIDDER. The Mayor and Council reserve the right to reject any and all bids. The bids may be presented to the Mayor and Council at their Regular Meeting on September 13, 2022, at 7:00 p.m., at City Hall, 414 High Street, Seaford, DE.

All applicable laws, ordinances and the rules and regulations of all authorities having jurisdiction over the WORK shall apply to the contract throughout.

Each BIDDER is responsible for reading and being thoroughly familiar with the CONTRACT DOCUMENTS. The failure of the BIDDER to do any of the foregoing shall in no way relieve any BIDDER from any obligation respective to their BID.

➤ Double spring over center door retainers on all vertical doors, retains doors in positive open or closed position. (Other type retainers not acceptable, i.e. cables, chains).

#### Shelving

- ➤ 18 gauge bright spangled galvanized shelves with hemmed dividers on 4" centers. Minimum 250 lbs. capacity rated.
- ➤ Shelves can be positioned vertically on 2" centers.

#### **Exterior Prime Paint**

- ➤ Body is to be completely immersed in electro-deposition gray epoxy prime paint featuring a zinc phosphate pre-coat and seal for additional corrosion protection.
- Prime paint is to be oven cured to provide a hard durable finish.
- Finish coat to match cab with clear coat added.

# **Spray on Bed Liner**

Line-X or approved equal, to cover compartment sides, headboard, floor, top of compartments and bed side of tail gate.

# **Interior Paint**

➤ Interior paint to be mid-gloss, mar resistant, light gray finish.

# Undercoating

➤ Body to be completely undercoated by the manufacturer of the body.

#### Installation

- Manufacturer of the body to supply a recommended installation process along with detailed installation instructions that conforms to all applicable Federal Motor Vehicle Safety Standards.
- > Further, manufacturer of the body to supply owner manual describing proper care and maintenance of body by user.
- > Completed unit delivered to city yard.

# **Body Warranty**

The following items to be covered by a minimum five (5) year limited warranty to first owner/user of record.

Continuous Door Hinge – Guaranteed not to fail to operate or come off product. Latches and Lock Cylinders – Guaranteed against failure.

**Shelves** – Guaranteed not to fail in bending under maximum 250 lb. rated load.

# Lighting

- ➤ Lighting to meet all applicable FMVSS 108 lighting requirements.
- ➤ Light harness to be encased in plastic loom and all wires colored for ease in troubleshooting.
- ➤ Wire harness must have connectors compatible with applicable Ford, GM and Dodge chassis without splicing.
- > Stop/tail/turn, backup and side marker lights recessed in aluminum light boxes at rear of body.
- ➤ Body end panels pre-punched for wires and box mounting.

# **Interior Compartment Lighting**

- All compartments to be illuminated with lights powered off taillight circuit.
- Manual toggle switches required on each light.

#### **Lighting Wire Retention**

Wires must be retained by mechanical fastening system. (Other types not acceptable, i.e. pressure sensitive).

#### **Fuel Fill Cup**

With proper degree of angle for proper fueling.
